**Establishment of Training Programs**: Weekly sales training meetings are held by the General Manager and/or Sales Manager. On at least a monthly basis, a sales and management training meeting is held as well. This is designed to enable our current personnel to acquire skills that could qualify them for higher level positions.

**Job Fairs**: Advanced Media Partners participated in the Bradley University job fair on February 13, 2025 to solicit resumes for all open positions, as well as educate attendees on careers in radio.

**Job Shadow:** Advanced Media Partners engages in job shadowing opportunities amongst high schools and other outreach programs. This year's connection with Greater Peoria Pathways allowed AMP to demonstrate the inner workings of the radio industry. During these periods, participants observe the workday of the business partners in a variety of areas. In sales, we show how to sell radio and the process involved. In Promotions, various marketing strategies are explained and what all goes into a remote broadcast setup. In programming, they work with our producers of our local shows with running the mixer/control board, producing promotional commercials and other technical duties. In Business, the participant is shown trafficking of commercials process and placement.
